INTRODUCTION

Since its establishment in September 1990, the Hong Kong Institute of Asia-Pacific Studies (hereafter, the Institute or HKIAPS) has been promoting and coordinating inter-disciplinary studies on Hong Kong and neighbouring Asian countries and communities within the Asia-Pacific region. The Institute aims to serve as a bridge between overseas scholars in Asia-Pacific studies and teaching and research staff at The Chinese University of Hong Kong (hereafter, the Chinese University or CUHK).

The Institute supports two major types of research activities: individual projects funded by or affiliated with the Institute, and long-term inter-disciplinary research programmes that constitute the backbone of the activities of the Institute. The latter activities are described at length in the following pages, while the former will be mentioned in particular segments of specific programme reports.

Message from the Director

This is a special year for the Institute, as it has reached a milestone in its development. Established in September 1990, the Institute will celebrate the 15th anniversary of its founding. A series of activities will be organized to mark this year. Along with this annual report, a memorial volume is being prepared to show a timeline for the Institute. In reaching 15 years of age, the Institute has reached adolescence. It is full of vitality and energy, ready to strike off in a new era at the beginning of a new century.

Indeed, a new era has just dawned, with the election of a new Chief Executive of the HKSAR in late June 2005. Donald Tsang has already assumed office, full of promises and the confidence to take Hong Kong on a new journey of togetherness and social unity. He has retained the services of Professor Lau Siu-kai as Head of the Central Policy Unit, meaning that the latter will be on leave from the University and the Institute for another two years.

The government has responded to the public's clamour for democracy and an enhanced participation in public affairs over the past two years, by providing new resources for supporting research on public policies. This is the first academic year that competitive research funds, amounting to \$20 million, for this purpose will be made available via a dedicated allocation in the Research Grants Council (RGC). The first round of \$10 million was open to competitive bidding in July 2005, when the University received 16 proposals from its staff. The Institute played a small part in helping some researchers to gather background materials to prepare their proposals. In all cases, the Institute helped to organize critiques on the proposals with the objective of improving their presentation before they are submitted to the RGC.

In order for the University to better prepare itself to respond to public policy research, the Institute has decided to reorganize its internal resources and structure. With the start of a new academic year in August 2005, the Institute will drop two programmes - Cultural Relations and Identities in East Asia and Political Development in Hong Kong. The resources for these two programmes will be redeployed to support a new Public Policy Research Centre, with Stephen Chiu as Director and Timothy K. Y. Wong as Associate Director. We anticipate that with this new centre, the close relationship between the Institute and the Faculty of Social Science will be further cemented. We shall also reach out further and more effectively to the community and make more visible contributions to policy making.

The staff of the Institute continued to contribute to public affairs in various capacities. For example, Liu Pak-wai was appointed to be a member of the Committee that reviewed the salary of the new Chief Executive. Yeung Yue-man and Sung Yun-wing were reappointed as Chairman and member, respectively, of the re-constituted Pan-Pearl River Delta Panel under the Central Policy Unit in January 2005. As Hong Kong has been a member of the new regional cooperative framework since June 2004, Hong Kong has required considerable input in time and participation at many levels within and outside the government. In term of research, the Institute has mounted many research and related activities, as reported in the Urban and Regional Development in Pacific Asia Programme report that follows.

The past year was notable for several reasons. First, it was the first year we had enjoyed the full support and encouragement of Professor Lawrence J. Lau as our new Vice-Chancellor. As a world-renowned economist, with expertise on the Asia-Pacific region, he offered us shrewd advice and words of wisdom. Second, in December 2004, the first four years of cooperation between this University and Fudan University in Shanghai with regard to the Shanghai-Hong Kong Development Institute was completed. In this cooperative effort, the Institute provided administrative support. Professor Lau decided that the existing administrative support arrangement would continue when a new phase of cooperation began in January, 2005. Third, this was also a year when I continued my activities with the Institute, for the first time as a Research Professor at the Institute, having retired as Professor of Geography in July 2004. I was also appointed

Emeritus Professor of Geography in April 2005.

With regard to other functions, the past year saw steady progress across different fronts. The Telephone Survey Research Laboratory was as busy as ever, with a cumulative tally of 569 surveys having been undertaken since its establishment in 1995. The publication unit recorded a cumulative total of 63 monographs and 159 occasional papers, with 2 monographs and 11 occasional papers having been published during the past year.

By and large, the year behind us was one of consolidation and reorganization. It was a time of reflection and appraisal, when emerging opportunities prompted us to restructure our programmes and redeploy our resources, so that in the years ahead, we will be able to make more effective contributions to society and the University. In our new mission, we hope to be able to continue to count on your support, both intellectually and materially.

Profiles of the Senior Staff

Prof. Yeung Yue-man 楊汝萬

With basic training in geography in Hong Kong, Canada and the United States, Prof. Yeung has had a rich and varied career that has spanned teaching, research, international development and university administration. He had been away from Hong Kong for almost two decades, studying in North America and working in Singapore and Canada, before being appointed Chair Professor of Geography at this University in 1984. Prof. Yeung has travelled to most countries in the Asia-Pacific region and has worked with many Asian research institutes and researchers. His research interests lie mainly in Asian cities, low-cost housing and policy studies and design for development, with particular reference to Pacific Asia. He has published numerous books and articles in international learned journals on these subjects. Apart from being the Director of the Institute, Prof. Yeung leads the Urban and Regional Development in Pacific Asia Research Programme. Prof. Yeung plays a very active role in serving the Hong Kong community through memberships in several public bodies providing key urban services, and he participates collaboratively in many regional and global research projects.

Prof. Sung Yun-wing 宋恩榮

Prof. Sung is currently Professor and Chairman of the Economics Department of the Chinese University of Hong Kong. He is Director of Institute of Economics, Associate Director of the Hong Kong Institute of Asia-Pacific Studies, and also Co-Director of the Hong Kong and Asia-Pacific Economies Research Programme of the same Institute at the Chinese University of Hong Kong. He is Editor of the Asian Economic Journal (2001 - present), Corresponding Editor (Hong Kong) of the Asian-Pacific Economic Literature (1987 - present), and member of the Editorial Board of The China Review (2000present). He is a member of the Board of Advisors of Shanghai University MBA Center (2004-present), and the Social Sciences Advisory Board of Lingnan University (2002-08). In public service,

he is a part-time member of the Central Policy Unit (2001-04), and a member of the CPU Panel on the Pearl River Delta (2003-04), which was reorganized as the Panel on Pan-Pearl River Delta (2005-present). He is a member of the Hong Kong Committee for Pacific Economic Cooperation (HKCPEC) (2004-06), and is also HKCPEC's Representative to the International Advisory Groups of the PECC Trade Forum. His research interests include international trade, economic development, the Hong Kong economy, and the Chinese economy.

Prof. Fanny M. Cheung 張妙清

Prof. Cheung, Ph.D. (Minnesota), Director of the Gender Research Centre, established the Gender Research Programme at CUHK in 1985. When she was Dean of the Faculty of Social Science in 1995-1996, she initiated the Gender Studies Programme. An active advocate for women's development in the community and a recognized women's leader in the Asia-Pacific region, she served as the founding chairperson of Hong Kong's Equal Opportunities Commission from 1996-1999. Her research interests in gender issues include gender roles, violence against women, women's health and gender equality. Other research interests in psychology include personality assessment and cross-cultural psychopathology.

Dr Matthew Ming-tak Chew 趙明德

Dr Chew received his Ph.D. in sociology from Princeton University. He has taught at the University of Hong Kong, the City University of Hong Kong and the Chinese University. His research interests include cultural sociology, cultural policy, globalization and consumption in China. He has contributed to several journals, including *Positions* and *Cultural Studies*. He is presently the coordinator of the Institute's Documentation Unit.

Prof. Kuan Hsin-chi 關信基

Prof. Kuan, Director of the South China Programme, is Professor of Government and Public Administration and the Chairman of

the Department. He is also the Director of CUHK's Universities Service Centre for China Studies. He has co-authored The Ethos of the Hong Kong Chinese and co-edited the first two volumes of China Review and China Review 1992, as well as China Review 1997. He has contributed to The China Quarterly, Studies in Comparative Communism, Asian Survey, *Iournal* of Comparative Commonwealth Studies and Pacific Affairs.

Prof. Lau Siu-kai 劉兆佳

Prof. Lau graduated from the University of Hong Kong in 1971 with a BSocSc degree in sociology and economics, and from the University of Minnesota in 1975 with a Ph.D. in sociology. He joined CUHK in 1975. His major research interests are comparative political and social development, society and politics in Hong Kong, and political development in traditional and modern China. He tackles both macroscopic and microscopic issues, such as political culture and political behaviour. His favourite approach is the comparative historical method. His publications include Society and Politics in Hong Kong (1982) and, with Prof. Kuan Hsin-chi, The Ethos of the Hong Kong Chinese (1988).

Prof. Liu Pak-wai 廖柏偉

Prof. Liu is currently Professor in Economics, Pro-Vice Chancellor of the Chinese University of Hong Kong, and Director of the Hong Kong and Asia-Pacific Economies Research Programme at the Chinese University of Hong Kong. He is Director of the EAEA (1997-2002, 2005-present), and member of Management Committee of Hong Kong Institute of Economic and Business Strategy (2002present). In public service, he serves as Director of the Hong Kong Institute for Monetary Research (2003-present), and Non-Executive Director of Securities and Futures Commission (2005-06). He is a member of many advisory committees, including the Panel of Arbitrators, which arbitrate on labour disputes (1999-2005), Process Review Panel for the Securities and Futures Commission (2000-04), Skills Upgrading Scheme Steering Committee (2000-present),

Manpower Development Committee (2002-present), Independent Commission on Remuneration for Members of the Executive Council and the Legislative Council of the HKSAR (2003-08), Land Advisory Committee (2003-05),Independent Building Package and Post-Office Commission on Remuneration Arrangements for the Chief Executive of the HKSAR (2005-06), and Hong Kong Committee on Pacific Economic Co-operation (1990-98, 2000-06). His research interests cover the areas of applied theory, labour market and employment, and the Hong Kong economy. Besides a continuing interest in economic theory, Professor Liu is interested in the empirical aspects of economics.

Prof. Shen Jianfa 沈建法

Prof. Shen is Professor and Head of Graduate Division in the Department of Geography and Resource Management. He is also Co-director of Urban and Regional Development in Pacific Asia Program of the Institute. He is a member of the Steering Committee of the Commission on Population and Vulnerability, International Geographical Union and an executive member of the Editorial Board of China Review: An Interdisciplinary Journal on Greater China. He obtained his PhD degree in Geography from the London School of Economics in 1994. His research interests focus on migration, urbanization, urban and regional development/ governance in China. He is the co-editor of China Review 2000 (2000), Resource Management, Urbanization and Governance in Hong Kong and the Zhujiang Delta (2002) and Developing China's West (2004). He has contributed to many international journals such as Urban Geography, Geoforum, Professional Geographer, The Geographical Journal, Planning A_{\star} Environment and International, Progress in Planning.

Prof. Tan Chee-beng 陳志明

Prof. Tan obtained his Ph.D. from Cornell University in 1979. He is Chairman of the Department of Anthropology and the Director of the Cultural Relations and Identities in East Asia Research Programme. His research interests include cultural change and

identity, ethnicity and ethnic relations, and indigenous peoples and development. He has been particularly interested in the study of Chinese overseas and, in recent years, has also conducted research in mainland China. He has published extensively on these subjects, as well as on Chinese popular religion.

Ms Wan Po-san 尹寶珊

Ms Wan received her BSSc and MPhil in sociology from CUHK. She is experienced in conducting sample surveys and in research in the field of Hong Kong studies. Her major research interests are the status of women and the state of the environment. Other interests include gender issues, the quality of life, social problems, and patterns of social change in Hong Kong. She is responsible for the Institute's publications and is Co-director of the Social Indicators and Social Development of Hong Kong Research Programme.

Prof. Timothy Ka-ying Wong 王家英

Prof. Wong received his Ph.D. in sociology at the University of Manitoba, Canada. He is currently a Research Associate Professor and coordinator of the Telephone Survey Research Laboratory of the Hong Kong Institute of Asia-Pacific Studies at The Chinese University of Hong Kong. Professor Wong's major research interests include cross-Taiwan-Strait relations and social and political development in Taiwan and Hong Kong. He has published a number of books and book chapters and has contributed to such academic journals as Nations and Nationalism, Journal of Contemporary China, Asian Perspective, Journal of East Asian Affairs, Social Development Issues, Democratization, Social Policy and Society, International Journal of Social Welfare, and Issues and Studies.

Prof. Yip Hon-ming 葉漢明

Prof. Yip (Ph.D., University of California, Los Angeles), Associate

Director of the Gender Research Centre, has published on gender/women's history, the history of the overseas Chinese, modern and contemporary Chinese socio-economic history, and the local history of China and Hong Kong. As a member of the Association for the Advancement of Feminism, the Hong Kong Women Christian Council and other community organizations, she considers the coordination of teaching, research and social practice her greatest challenges at present. Taking power in history as her focal point of reflection in recent years, she is interested in exploring the historical contexts of developments and changes in the operation of power in human society. She is also interested in ways of exposing the historical roots of human manipulation and resistance in daily life. Related issues include marginalization and subordination, and subversion and struggle in the fields of gender, class and ethnicity.

Prof. Yu Xingzhong 於興中

Prof. Yu obtained a BA in English Literature from Lanzhou University in China, and an LLM (Master of Laws) and SJD (Doctor of Juridical Science) from the Harvard Law School. He teaches Chinese law and constitutional law at the Department of Government and Public Administration. He has been the Director of the Chinese Law Programme since March 2003. He has previously served as a Lecturer on law at the Harvard Law School (September-December 1999), a Senior Research Fellow in East Asian Legal Studies, Harvard Law School (1998-1999), a Visiting Professor at Beijing University's Department of Law (Spring 1998) and as an Associate (Chinese Legal Specialist) with the Chicago office of Baker & McKenzie (November 1995-February 1998). He was also a Visiting Scholar at Columbia Law School (1988-1990) and a Visiting Fellow at the Australian National University (1984-1986). His research interests include social and political theory, cultural studies of law, jurisprudence, constitutional and administrative law, constitutionalism in Hong Kong and China, comparative law, Chinese legal history, and PRC law. He has contributed to various journals and book projects.

Objectives

This inter-disciplinary research programme is designed to facilitate and consolidate diverse research interests in cultural development within and cultural interactions among East Asian countries at the Chinese University of Hong Kong as well as in the broader Hong Kong academic community. Cultural relations among Asia-Pacific countries have gained prominence in the post-cold war era, as cultural activities carry new political meanings and commodified cultural items are promoted and traded across national and regional boundaries. The research projects focus on a broad array of identities and cultural relations in East Asia, including media and popular culture; youth culture and education; ethnic, national, and pan-Asian identity; cultural tourism; cosmopolitan culture and democratization; and food, cuisine and cultural change.

There are four categories of research activities in the Cultural Relations and Identities Research Programme. They are: tradition, change and identity; culture, identity and nationalism; cultural unity and diversity in Asia, and transnationalism and global culture. During the past year, programme members were active participants in international conferences and have published in journals and books.



The Gender Research Centre, which was founded as Gender Research Programme in 1985, is the first research unit on gender and women's issues in Hong Kong. Our mission is to promote knowledge in gender research and women's studies and to support action on enhancing gender equality and women's status. Given the interdisciplinary nature of gender research, members include scholars from Social Science, Humanities, Education, Medicine, Business Administration, and other interdisciplinary fields. Other faculty and staff of the university may join as members. Non-CUHK members and students may also join as affiliates.

In addition to facilitating networking and collaboration among gender scholars, the Gender Research Centre also organizes activities to promote gender research, raise gender awareness, and address gender issues.

Workshop

The 2005 Annual Gender Role Workshop on "Beijing-Plus-Ten" was held on 14 May 2005. The aim of the workshop was to reviewing the implementation of the 12 Areas of Concern in the Beijing Platform for Action (BPFA) at the governmental level and local NGOs level ten years after the 1995 UN Fourth World Conference on Women held in Beijing. To review the achievements and challenges of implementating BPFA in Hong Kong, we conducted a survey by inviting NGOs and women's groups to share their experiences. Both survey respondents and participants attending the workshop recognised that women's conditions in some particular areas have improved over the past 10 years, but they also urged the government to pay more attention to "Women and Violence", "Women and Health" and "The Girl-child". Their opinions would be compiled and submitted to Women's Commission for reference.

Objectives

Economic competition and cooperation between Hong Kong and other Asia-Pacific countries constitute this Programme's main interest and the thrust of our investigation. Major research topics include the Hong Kong economy and its transformation; government policies; the economic integration of Hong Kong, the mainland and Taiwan; trade and investment relations between Hong Kong and economies in the Asia-Pacific region; and, intraregional trade and investment.

Asian Economic Journal

This is the fifteenth year in which our Programme has jointly published the *Asian Economic Journal* for the East Asian Economic Association with our partner in Japan. Since 1997, the number of issues published each year has been increased from three to four. Professors Liu Pak-wai and Kwong Kai Sun have served as the Secretary General of the East Asian Economic Association from 1997 to 2002, and from 2003 onwards respectively. Professors Sung Yun-Wing, Kwong Kai-Sun, and Chou Win-Lin have served as Managing Editor of the journal from 1997 to 2000, 2001-2003, and from 2003 onwards respectively. Professor Sung Yun-Wing served as Editor of the Journal since 2001. In 2005, Professor Liu Pak-Wai was elected Director of the EAEA, and Professor Lawrence Lau was elected President of the EAEA.

Impact

As a result of their expertise, the Co-Directors of the programme have served in many public and professional advisory committees which are listed below. These professional activities, which are related to HKAPE, have an impact on the local community as well as the Asia-Pacific. They also help to project the image of the Research Programme.

Professor Liu Pak-Wai is the Director of the EAEA, and a member of Management Committee of Hong Kong Institute of Economic and Business Strategy. In public service, he serves as Director of the Hong Kong Institute for Monetary Research, Non-Executive Director of Securities and Futures Commission. He is a member of many advisory committees, including the Panel of Arbitrators (which arbitrate on labour disputes), Process Review Panel for the Securities and Futures Commission, Skills Upgrading Scheme Steering Committee, Manpower Development Committee, Independent Commission on Remuneration for Members of the Executive Council and the Legislative Council of the HKSAR, Land and Building Advisory Committee, Independent Commission on Remuneration Package and Post-Office Arrangements for the Chief Executive of the HKSAR, and Hong Kong Committee on Pacific Economic Co-operation.

Professor Sung Yun-Wing is Editor of the Asian Economic Journal, Corresponding Editor (Hong Kong) of the Asian-Pacific Economic Literature, and a member of the Editorial Board of The China Review. He is a member of the Board of Advisors of Shanghai University MBA Center, and the Social Sciences Advisory Board of Lingnan University. In public service, he is a part-time member of the Central Policy Unit (CPU), and a member of the CPU Panel on the Pan-Pearl River Delta. He is a member of the Hong Kong Committee for Pacific Economic Cooperation (HKCPEC), and is also HKCPEC's Representative to the International Advisory Groups of the PECC Trade Forum.

Asian Economic Journal is a journal that is devoted to publishing articles on the Asian economies which are based in the Asian region. The journal has a wide circulation not only in Asia but also in Europe and North America. Its readership is expected to increase as economists worldwide focus their attention on the economic successes and problems of the Asia Pacific region. Since 2004, all issues of the journal have been published on time and it is eligible for inclusion in the Social Science Citation Index. The Editorial Committee is very broadly based. It includes leading economists from all major East and Southeast Asian countries. Because the journal is edited, printed and published at CUHK, it bears the name of CUHK together with The International Centre for the Study of East Asian Development on the front cover as the two institutions which produce the journal. The Secretariat of the East Asian Economic Association is also located at CUHK using HKIAPS as its address. The journal and the location of the Secretariat have promoted the image of CUHK in general, and HKAPE and HKIAPS in particular as institutions active in research within the Asia-Pacific region.

Political Development of Hong Kong

Objectives

The main objective of the Programme has been to study political changes in Hong Kong and their underlying factors. The current foci of the Programme are on the issues of leadership, political culture, popular elections, institutional reforms leading to more accountability and democracy, policy reforms, and, last but not least, the relationship between China and Hong Kong. With new members joining the Programme, there is potential to widen the range of research topics to be covered in the years to come.

Research Activities

Both Prof. Lau Siu-kai and Prof. Kuan Hsin-chi continue to focus on studying the patterns of political changes in Hong Kong, particularly in areas such as the relationship between political leadership and governmental reforms, the connections between cultural and value changes on the one hand and the democratic transition, social learning, and the development of the electoral process and political parties as respected institutions on the other.

With Prof. Ma Ngok and Prof. Lam Wai-man as new members, the programme launched a collaborative research project on the 2004 elections of the Legislative Assembly. One of the two funding proposals was awarded an RGC Earmarked Research Grant. A workshop on those elections was held on campus on 8 April 2005.

Since many commissioned research projects of the Telephone Survey Research Laboratory of the Institute are about local politics, the Programme has provided technical and staff support to the Laboratory and is instrumental in its smooth operation.

The Programme continues to collect related documents and materials on the District Council elections and the Legislative Council elections, particularly the election datum. A data book will be published after the elections of Legislative Council are held.

The political ecology of Hong Kong has undergone profound changes since the July 1 demonstration of 2003. To keep track of the political and social developments, the Programme has composed a chronology that covers important day-to-day events.

The following research projects are currently being sponsored by the Programme:

"Democratization and Value Change" by Prof. Kuan Hsin-chi and Prof. Lau Siu-kai:

This is part of the regional collaborative project "East Asian Democratization and Value Change" involving Mongolia, South Korea, mainland China, Taiwan, Hong Kong, the Philippines, and Thailand. A territory-wide household survey was launched in September 2001. More than 800 people were successfully interviewed during the fieldwork. A progressive report was submitted in 2002 and a manuscript for the chapter on Hong Kong entitled "Noises and Interruptions – the Road to Democracy" has been published as an occasional paper by Prof. Lam Wai-man and Kuan Hsin-chi.

"Political Change and Civil Servants in Hong Kong" by Prof. Lau Siu-kai:

The project is funded by the Chinese University of Hong Kong.

"Political Culture and Political Participation in China, Taiwan, and Hong Kong" by Prof. Lau Siu-kai, Prof. Kuan Hsin-chi, Prof. Andrew Nathan [Columbia University], Prof. Hu Fo [National

Taiwan University], Prof. Chu Yun-han [National Taiwan University] and Prof. Shi Tian-jian [Duke University]:

The project was funded by, the National Science Foundation, the Chiang Ching-kuo Foundation, and the Luce Foundation, among others. The questionnaire survey that was launched in Hong Kong was partly funded by the Center for Pacific Rim Studies, University of California, Los Angeles. Members of the research team are in the process of writing the ten chapters to be included in a forthcoming book with the tentative title of "Political Participation in Three Chinese Societies". Kuan Hsin-chi and Lau Hsin-chi presented a chapter on "Institutions and Political Participation in Three Chinese Societies" at an international conference on "The Transformation of Citizen Politics and Civic Attitudes in Three Chinese Societies" held in Taipei on 19 to 20 November, 2004.

Collection of Data

The Programme continues to collect first-hand research materials on Hong Kong's political scene. Aside from newspaper clippings, the Programme also collects unpublished research reports from various social and political organizations.

The Programme has built up a comprehensive collection of documents and materials related to elections and electoral campaigns in Hong Kong. The collection forms a useful database for the study of future elections.

International Exchange

The Programme is also a partner in a comparative study of political culture and political participation in Hong Kong, Taiwan, and mainland China. This cross-cultural study is being coordinated by Prof. Andrew Nathan of Columbia University. The researchers involved come from Hong Kong, Taiwan, mainland China, and the United States. This trilateral project attempts to chart the changes in the political culture and development in the Greater China area partly on the basis of two major surveys

conducted in 1993 and 2001, respectively. The Hong Kong team (composed of Prof. Lau Siu-kai and Prof. Kuan Hsin-chi) was responsible for conducting questionnaire surveys in Hong Kong, which were completed in the summer of 1993 and fall of 2001. This trilateral project has formed the core of a new Asian Barometer Project that includes nine nations and Hong Kong as a non-nation member.

The research project, "The Legislative Council Elections in 1998", has attracted attention overseas and subsequently been incorporated into a 14-nation collaborative project, "The Comparative National Elections Project (CNEP)", coordinated by Prof. Richard Gunther of Ohio State University. A looser affiliation has also been established with another and larger international research project, a "Comparative Study of Electoral Systems (CSES)", coordinated by The Institute of Social Research at the University of Michigan.

Social Indicators and Social Development of Hong Kong

Programme Directors: Prof. Lau Siu-kai (on leave)

Ms Wan Po-san

Objectives

The Programme focuses on the measurement and study of social development in Hong Kong. Its prime purpose is to build up a set of longitudinal data on the subjective and objective dimensions of social conditions and social change. It is hoped that the availability of these data will facilitate not only analyses of patterns of social change and explorations of social issues and problems but also contribute to the evaluation and formulation of public policy.

Conference

"2004 Conference on Social Image and Social Indicators: Hong Kong and Taiwan"

This conference was organized in cooperation with the Institute of Sociology, Academia Sinica. It was held on 10-11 September 2004 at The Chinese University of Hong Kong. Seventeen papers were presented. A conference proceedings is expected to be published by September 2005.

Research Activities

Highlights of the main activities during the past year are underlined as follows:

"Social Indicators Survey Series" coordinated by Prof. Lau Siukai and Ms. Wan Po-san

The Programme has been conducting a series of biennial

territory-wide household surveys since 1988. These periodic surveys aim to measure the scope and extent of significant aspects of social change in Hong Kong by focusing on the perceptions, values, feelings, aspirations and sense of well-being of the Hong Kong people on various important aspects of their daily lives.

The survey "Crisis and Reintegration: Indicators of Social Development in Hong Kong 2004" is funded by the Research Grants Council's Competitive Earmarked Research Grant (HK\$1,554,000) and is being conducted in collaboration with the Centre of Asian Studies of the University of Hong Kong and the Department of Applied Social Sciences of the Hong Kong Polytechnic University. The CUHK team members include Prof. Cheung Yuet-wah, Prof. Stephen W. K. Chiu, Prof. Kuan Hsin-chi, Prof. Lau Siu-kai, Prof. Rance P. L. Lee, Prof. Lui Tai-lok and Ms. Wan Po-san.

Special topics in the 2004 survey included: (1) fertility and cosmopolitan ethos; (2) flexible employment and Hong Kongmainland relation; (3) political and legal attitudes; (4) health and class. The survey fieldwork was launched in May 2004. A general report, entitled Indicators of Social Development: Hong Kong 2004, is expected to be published by the end of 2005.

In addition to the household survey, a new series of topical polls was launched to take the pulse of the society and to provide timely information on new developments that fall outside the regular trend series. Three telephone polls on population problem, healthcare financing and mass media were completed in February 2004, October 2004 and April 2005, respectively.

"A Baseline Study on Quality of Life in Macao 2005"

The study is commissioned by the Center for the Study of of Life Quality of the Government of Macao Administrative Region and is being conducted in collaboration with the Centre of Asian Studies of the University of Hong Kong. The CUHK team members include Prof. Yeung Yue-man, Prof. Chan Ying-keung, Prof. Timothy Ka-ying Wong and Ms. Wan Posan. A territory-wide household survey will be launched in August 2005 and the study is scheduled to be completed in

February 2006.

"A Comparative Study of the Social Image of Taiwan and Hong Kong"

CUHK team: Prof. Lau Siu-kai and Ms. Wan Po-san

Taiwan team: Prof. Chang Ying-hwa, Prof. Chiu Hei-yuan, Prof. Fu Yang-chih, Prof. Michael Hsin-huang Hsiao and Prof. Yi Chin-chun

This project is being conducted in collaboration with the Institute of Sociology of the Academia Sinica, Taiwan. A telephone survey will be conducted once or twice a year to gauge the perceptions, values and subjective well-being of people in both societies. The core questions of the questionnaire will be kept unchanged as far as possible so as to detect social trends and changes, while questions on special topics will be flexible enough to reflect changes in social conditions.

The sixth survey, focused on subjective well-being and sociopolitical trust, was carried out in December 2004. It is funded by Mr. Richard Liu.

"An Exploratory Study of Public Opinions on the Impact of Comprehensive Social Security Scheme in Hong Kong" by Prof. Wong Chack-kie (Principal Investigator), Prof. Tang Kwongleung and Prof. Wong Hung

This study aims to identify subjective indicators of public opinions on the impact of the social policy on poverty alleviation and employment promotion. The identification of these indicators will help policy makers to determine whether the policy is effective, on the basis of public perceptions, for achieving its intended consequences. The study is partly funded by Mr. Richard Liu.

South China

Programme Director: Prof. Kuan Hsin-chi

Objectives

The aim of the Programme is to encourage research activities related to contemporary Chinese studies by the faculty of the Chinese University through awarding research grants. The Programme supports a wide variety of discipline and topics, while studies that focus on or relate to the region of South China are preferred in principle. In recent years, greater emphasis has been placed on the development of in-house team projects, apart from the support given to projects undertaken by individual faculty members. In terms of intellectual orientation, the Programme continues to favour research problems related to the withering of outdated systems and the evolution of new institutions and practices in South China's economic, social, mass media and political arena. From the very beginning, the Programme welcomes inter-disciplinary cooperation. It also maintains links with researchers and research units in the field in other parts of Greater China.

Research Activities

The International Conference on The State of Contemporary China held on 5-6 January 2004 had been reported previously. As a follow-up, papers of the conference were selected for revision and subsequently submitted to *The China Journal* for publication as a special issue (for details please consult the Publication section below). Some other papers presented were also revised and translated into Chinese for publication in Mainland Chinese venues.

Three projects, including "Social Roots of Economic Development: The Case of Rural China" by Prof. Lau Chong-chor, "Testing the Chinese Entrepreneurial State Perspective: The Preservation of an Archaeological Site in Guangzhou" by Prof Ma

Shu Yan and "Perceived Benefits of Cancer Self-help Groups" by Mok Bong-ho, were completed.

Prof. Fung Ka-yiu had an on-going project on "Venture Capital in Hong Kong and South China," and Prof. Ma Shu-yun continued to work on the project "The Role of the State in Economic Transformation."

Two projects dealing with the developmental state were in good progress: "An Empirical Investigation of Local State Corporation in Chinese Cities" by Prof. Peng Yusheng and "State Capacity and Regional Disparities" by Prof. Wang Shaoguang.

Prof. Tsao King-kwun, the principal investigator for the project "Local Elite Transformation in Reform China," was on long leave and away from Hong Kong for the report period.

The group research project on Civil Society in China was established in early 2002 to replace "the Comparative Study of Civil Organizations in Chinese Societies." Prof. Chan Kin-man from the Department of Sociology continued to serve as the convener of the project. Members include Prof. Kuan Hsin-chi, Prof. Wang Shaoguang, Prof. Lui Tai-lok, and Prof. Joseph Man Chan. The aim of the group project is to promote research on the impacts of the development of civil organizations on the society, economy and political system.

During the year, Prof. Wang Shaoguang continued to work on research on the associational revolution in China as the principal investigator. This research was funded by the Chiang Ching-kuo Foundation for International Scholarly Exchange and the Aspen Institute. Under Prof. Wang's supervision, a M.Phil. and a Ph.D. student were involved in the research related to the associational revolution. Specifically, the M.Phil thesis examined three different types of associations of entrepreneurs or *getihu* in Shanghai in the light of state-society relations and the Ph.D. dissertation dealt with the movement of the association of property owners in Shenzhen.

Prof. Chan Kin-man was working on the social, economic

and political impact of business organizations in Guangdong and the dynamics of civil organizations in China, both funded by the Programme. The former research focused on the evolution of the chambers of commerce and various trade associations in Guangdong from Qing times to the contemporary period. Sociologists and historians from the Sun Yat-sen University in Guangzhou were involved in the collaborative research. Manuscripts resulted from the business organizations research are being revised and edited with a view for publication as a volume at the end of the year.

Inter-institutional Cooperation

The group project of Civil Society in China maintained deep collaboration with the Research Center for NGOs in South China of the Sun Yat-sen University in Guangzhou in organization of research activities and exchanges on the development of civil society in the region. Prof. Chan Kin-man was actively involved in the managerial and research work of the Center. The following research projects were undertaken under the auspice of that Center:

Objectives

The Programme promotes and facilitates research on economic development and social change in the Asia-Pacific region through studies on urban and regional development. A huge number of books and other publications have appeared.

During the past year, the Programme continued largely with its regional studies on China. It has initiated research on the Pan-Pearl River Delta region following its establishment as a regional cooperative framework in June 2004, as reported below. Otherwise, it has been a year of consolidation following the previous year of exceptional rich research output.

Research Activities


In the past year, the Programme has concentrated on research and activities related to the formation of the Pan-Pearl River Delta regional cooperation framework in June 2004. First, taking advantage of the currency of the subject, a development forum was organized on 13-14 December 2004, in collaboration with the Central Policy Unit, on the Pan-Pearl River Delta. Scholars and officials from the 9+2 regional units, together with representatives from Beijing and Singapore, were invited and presented papers. The first day of the forum was held at the Hong Kong Convention and Exhibition Centre, drawing a large crowd from community, including the diplomatic corps and the media. The sessions on the second day were held on campus of the University. A book arising from the papers presented at the development forum is in the final stage of preparation, as this report went to the press.

At the same time, another book project, also on the Pan-Pearl River Delta to be written in English and to be published by The Chinese University Press, has been launched, as the fifth book in the series of regional studies on China. Some of the authors from 9+2 who attended the development forum were involved. It is anticipated that the book would be published in late 2006.

In parallel with the above efforts, a series of research findings on the infrastructure development in the Pan-Pearl River Delta has been mounted in our Occasional Paper series. So far in 2005, three occasional papers on superhighways, railroads, port and waterways have been published. Another two papers on airports and power supply will complete this series. Progress on them is underway.

Chinese Law

Programme Director: Prof. Yu Xingzhong

Objectives

With China's resumption of sovereignty over Hong Kong on 1 July 1997 and the increasing economic and cultural exchange, epitomized in the CEPA arrangement, between Hong Kong and the Mainland ever since, there is an urgent need for better understanding of the Chinese legal system and its interaction with the common law in Hong Kong. Accordingly, current work of the Chinese Law Programme is focused on issues relating to the interface between the legal system of Hong Kong and that of the Mainland.

Website

The most important development of the Chinese Law Programme in the 2004-2005 academic year is the establishment of a website dedicated to Chinese legal studies. As a research tool, this website is designed to study Chinese law in a broader cultural context and from a comparative perspective, focusing on the issues specific to Hong Kong in relation to Chinese law and legal system and issues relating to law and disability, law and rural areas, law and gender studies, and law and animals, which are usually underrepresented in many Chinese law websites. By focusing on these issues, this website may emerge as a website having its own unique identity.

In collaboration with the Hong Kong Trade Development Council (HKTDC), the Programme continued with its training courses on Chinese law, which have attracted interested persons in Hong

Kong's professional world. The courses, covering more than ten subjects on Chinese law, usually run for two and half months and constitute part of the curricula for Chinese Business Law Certificate Programme offered by the HKTDC. Instructors were specialists or professors of relevant fields serving in Hong Kong or the Mainland.

He spoke on BBC, CNN, RTHK, TVB and other television and radio stations on numerous occasions, addressing Chinese and Hong Kong legal issues as they affect daily life of Hong Kong people. Mr. Ong has also been involved in providing legal assistance to Hong Kong citizens involved in Chinese legal system. He continued to assist individuals who were wronged or mistreated by the legal system or personnel of the Mainland in getting justice or compensation. He also was a lecturer on Chinese law for legal training classes organized by local communities.

FUNCTIONAL SERVICES

Documentation Unit

Coordinator: Dr Matthew Ming-tak Chew

In the past year, the Documentation Unit has continued to build up its collections. 119 items have been added to the Hong Kong Collection and 354 items have been added to the Asia-Pacific Collection. The total number of books, periodicals, and other reference materials reaches 48,371. Similar to the past, the DU pursues the strategy of acquiring basic reference materials on the one hand and items of interest that are not generally acquired by major academic and public libraries on the other hand. Such items of interest include original research data, regular and occasional government publications, reports by private organizations, unpublished survey compilations, studies by agencies and academic institutions, documents that are prepared for the private use of particular organizations or groups. We are currently more selective in acquiring these items than before as some of them have become available through the internet.

One of the most valuable assets of the DU is its collection of Hong Kong newspaper clippings from 1955 to 2000. It is one of the longest running collections of Hong Kong newspaper articles, remarkable in its breath of coverage, continuity, and system of classification. It has been a main attraction for our visitors and has functioned as a source of information supporting numerous fields of Hong Kong studies. Since 1998, the DU initiated a project to convert the collection of Hong Kong newspaper clippings into an electronic database. Despite of the lack of funding and technical difficulties, progress has been steady over the years.

The DU's reading room had 31 visitors in the past year. 12 of them were from outside the Chinese University. The reading room also continues to provide its archival function and services to the Institutes' research programmes and the University.

External Liaison

Coordinator: Prof. Timothy Ka-ying Wong

Prof. Timothy Ka-ying Wong is responsible for external liaison work of the Institute. This is a duty of a rather regular and routine nature. The overall objective is to publicize the activities of the Institute so that the public and concerned groups or persons can be informed of our work, make use of our research results and take part in our activities. External liaison has three main components:

Publicity about our publications includes preparing and issuing press releases to the media, distributing information sheets and order forms to relevant institutions and individuals, and liaising with our distributors.

Publicity about our conferences and seminars includes preparing and issuing press releases, sending invitations and publicity materials to the media, arranging and facilitating the reporting work of the press, and assisting the organizing committees to handle enquiries and public relations.

Liaison with overseas institutions and individuals includes the handling of enquiries and the exchange of information and publications.

During the last year, over 60 scholars from the mainland and overseas have visited the Institute, 4 seminars, forums or conferences have been held, and 10 occasional papers and 1 research monograph have been published. On the whole, our guests and visiting participants were pleased, and the coverage of our seminar/conference activities by the media was satisfactory. Our publications were also made known and distributed in an effective manner.

Publications

The aim behind the publications of the HKIAPS is to disseminate and promote research on social, economic and political developments in Hong Kong and the Asia-Pacific region. It is hoped that the extensive and effective dissemination of our research findings will broaden their intellectual and social impact, and allow more donations to be solicited for studies in the applied social sciences.

Scholars both inside and outside the Chinese University are welcome to submit manuscripts for consideration. The manuscripts received are evaluated by the Editorial Committee in collaboration with invited reviewers of relevant specialities. Priority in publication is given to the results of research undertaken by academics affiliated with the Institute and related to the domains of the established strategic research programmes.

Five publication series, namely the Research Monograph Series, Occasional Paper Series, the Shanghai-Hong Kong Development Institute (SHKDI) Research Monograph Series, the SHKDI Occasional Paper Series and the USC Seminar Series, are regularly produced. The first four series are mostly the results of research undertaken by scholars at the Institute. The USC Seminar Series publishes selected research papers presented at the seminars of the Universities Service Centre for China Studies. In addition, the Institute publishes the *Asian Economic Journal* for the East Asian Economic Association.

Telephone Survey Research Laboratory

Coordinator: Prof. Timothy Ka-ying Wong

The Laboratory

Established in May 1995, the Laboratory can handle over 30 telephone lines, all connected to the CATI (Computer Assisted Telephone Interview) system operated through a main server. It can cope with the demands of large samples under time constraint.

Objectives

- a. To provide a telephone survey laboratory to researchers at the Chinese University who want to use a telephone interview technique to facilitate their research.
- b. To enable the development of new research interests using the telephone interview method.
- c. To collect panel public opinion data of academic and social value.
- d. To serve as a link between the Chinese University and the public by regularly offering results of survey polls on public issues.

Accomplishments

Over 560 commissioned surveys have been completed since the establishment of the Laboratory (61 surveys in the past year).

Our survey findings have been widely covered by the media, thereby helping to raise the profile of the Institute and the Chinese University.

The Laboratory has attracted an increasing number of researchers from academic circles and the media who want to use telephone survey as an alternative method of data collection.

With the improving financial situation, we have designed and launched our panel surveys for academic research. We have trained and pooled over 70 experienced interviewers from amongst CUHK students as well as students from other universities, providing them with not only a good source of income but also the valuable experience of conducting telephone survey research.

We have conducted several seminars for secondary schooland technical college students and introduced them to the methodology and interpretation of opinion polling.

Policy

The Laboratory welcomes the sponsorship or commission of surveys; it is also open to collaboration with interested persons or organizations.
