Foreword

Introduction

About the Subject Content

The Asian Pacific countries have been drawing world attention, especially since the last decade. The so-called "five Asian Dragons" including Hong Kong, Japan, Taiwan, Singapore and South Korea are accumulating tremendous wealth because of sharp growth in their annual gross domestic product (GDP) and export volume. Typical forecasts predict that these economies will be ahead of average growth and that their total GDP may rival Western Europe's in 1992. According to the *Economist* (October 25, 1986) the average income of the Japanese in 1986 was higher than the Americans'. It also speculated that, by the year 2023, the average income of the Taiwanese would be greater than that of the North Americans'. And by 2032, the South Koreans' will exceed the Americans'. There is also the possibility of economic integration in this region. This integration, (Hong Kong, Shenzhen and the South China area forming one such "triangle" and Singapore, Johore (Malaysia) and Batam Island (Indonesia) forming another), could produce formidable regional economic forces. Consequently, politicians keep their eyes on their ever changing political development. Economists study the rapid development in their economic systems. Businessmen are trying hard to take on this lucrative market. Information on these political, social, economic and business environments are crucial for cross-cultural research, business decision making and foreign economic policy.

A comprehensive listing of core reference sources and publications on the political, social, economic and business environments of these Asian countries will be a valuable research tool. This research project was undertaken with this objective in mind.

As a result, the rich collections of the libraries of The Chinese University of Hong Kong (CUHK) was selected for this purpose. CUHK is a depository library of all publications printed or published in Hong Kong under the British Registration Ordinance. It has also collected extensively on China, Japan and other Asian countries. Its rich resources represent its dedication and commitment to Asian Studies.

Because most of the vital changes in these countries happened in the eighties, this project emphasizes the contemporary issues of the last decade. Publications available in CUHK including monographs, periodicals, serials, government publications, statistics, conference proceedings, working papers, theses, dissertations, microform and audio-visual materials published between 1980 to 1990 in English language are covered in this work as follows:

- Vol. I: Asia, East Asia, Japan, South Korea and Taiwan
- Vol. II: China and Hong Kong
- Vol. III: Southeast Asia, Indonesia, Malaysia, Philippines, Singapore and Thailand

About the Technical Aspect

Every library record was retrieved from the University Library's automated system – DOBIS/E – and was transferred into this bibliography through the Bibliolink and Procite software. While at every step care was taken to provide an accurate coverage, there are still some records not being retrieved for this work. They included records not yet entered into DOBIS/E at the cutoff date in April 1991. All serials were included but the holdings of these serials were not available in DOBIS/E at that stage; users of this work are reminded to check with libraries for their detailed holdings. The subject headings in this bibliography followed U.S. Library of Congress Subject Headings. Users can therefore do the cross-reference more efficiently. The location and the call number

of each title were also included to direct users in the title search.
