
2015年9月,亞太所開始兼任全球中國研究計劃秘書處,該計劃為跨學科研究項目,聚集香港中文大學各學院和研究單位的學者,以推動研究中國全球發展為使命。

Established in 1990, the Hong Kong Institute of Asia-Pacific Studies (HKIAPS) aims to promote multi-disciplinary research on social, economic and political development. To foster academic exchange, the Institute organizes public lectures, forums, seminars and international conferences regularly. Research findings are disseminated to the public through the publication of research monographs and occasional papers.

Since September 2015, HKIAPS has also served as the Secretariat of the Global China Research Programme, which has a mission to promote research on China's global engagement. It is a multi-disciplinary programme synergizing the concerted effort of various members of faculties and research institutes of The Chinese University of Hong Kong (CUHK).

# 華人家庭研究中心

#### Centre for Chinese Family Studies (CCFS)

華人家庭研究中心旨在成為一個以研究華人家庭為核心的跨學科、跨地區的學術組織。我們既關注生活在各個華人社會(如中國內地、香港、澳門和台灣)的家庭,也關注移民家庭(如從中國內地移民到香港或從華人社會移民到美國的家庭)。

我們的目標是為關心華人家庭福祉的學者提供一個開展學術交流與合作的平台,亦通過此平台讓公眾了解有關的科研成果。

CCFS aims to be a cross-disciplinary and cross-regional academic organization with a focus on studying families of Chinese descent. Our members conduct research not only among families who originated and reside in Chinese societies (e.g. mainland China, Hong Kong, Macao, and Taiwan), but also among families who have migrated between Chinese societies (e.g. from mainland China to Hong Kong) or from Chinese to non-Chinese societies (e.g. to the United States).

Our goal is to establish a platform for promoting empirical investigations and intellectual exchanges among scholars concerned about the well-being of families of Chinese descent, and also for disseminating such knowledge to the general public.





### 社會創新研究中心

#### Centre for Social Innovations Studies (CSIS)

社會創新研究中心旨在促進於社會 創新和行為改變領域的研究與知識 轉移,深化並擴大學術界與社會和 公眾之間的交流合作。中心的願景 是進行具社創性的研究,為香港社 會提供創新型方案。

近期項目包括:透過人文藝術開展可持續發展教育、減廢與減塑議題、公平工作與不穩定勞工,以學生學辦社會創新工作坊。主要以學生參與行動研究、連結社會持分者的方法探尋社會議題的解決方案。本中心的執行委員會包括社會工作、新聞學、性別研究和文化研究領域的跨學科頂尖學者。

CSIS aims to promote research, knowledge transfers, and exchanges among practitioners, academics, and the general public in the field of social innovation and changemaking. Our vision is to raise the visibility of socially innovative research and solutions in Hong Kong society.

Our recent projects include sustainability education through art and humanities, plastics and waste reduction, fair-work and precarious labour, and a Social Innovation Lecture Series. Engaging students in action research, we connect stakeholders and seek solutions. The members of our Executive Committee include leading interdisciplinary scholars in social work, journalism, gender studies, and cultural studies.



# 社會與政治發展研究中心

#### Centre for Social and Political Development Studies (CSPDS)

本中心下設香港社會指標與社會 發展研究項目,旨在量度和評估香 港的社會發展,蒐集一套涵括主觀 和客觀數據的縱向時序資料,據之 以分析社會事項和問題,並探討社 會變遷的模式。 **CSPDS** aims to explore and summarize experiences and lessons from the practice of "One Country, Two Systems"; to generate scientific and applied theories and formulate relevant policies for the reference of stakeholders from different sectors of society; and to stimulate local research social political and transformations. Its concrete objectives include: Analyzing the structure and special nature of social class and political groups in Hong Kong; promoting high-quality research on local society, politics, and related policies; unearthing and developing think-tank talent through related research; and providing a platform for rational and evidence-based discussions on local social and political developments.

The Social Indicators and Social Development of Hong Kong Project is operated under the auspices of the Centre. The Project focuses on measuring and studying social developments in Hong Kong. Its prime purpose is to build a comprehensive system of social indicators for Hong Kong, consisting of a set of longitudinal data on the subjective and objective dimensions of social conditions and social changes in the territory. Such data will contribute to evaluations and formulations of public policies as well as to analyses of patterns of social change and explorations of social issues and problems.















### 城市創新研究中心

#### Centre for Urban Innovations (CUI)

目前的研究項目包括:建設碳中和與氣候應變能力高的香港市鎮;智慧城市和智慧出行倡議下的低碳交通、市民幸福感及地球健康;保育香港北部都會區內的農業用地;馬鞍山鐵礦場的口述歷史;及從人有權使用空間達至多維度福祉的角度審視《香港規劃標準與準則》。

CUI was established to provide a platform for interdisciplinary and innovative research-related activities. CUI aspires to promote multi-stakeholder collaboration to achieve the United Nations' Sustainable Development Goals and the New Urban Agenda, increase resource productivity, enhance ecosystem service values, promote green economic developments, and boost social justice for human beings to flourish. CUI aims to conduct research-related works that will enhance and exert positive impacts on the health and well-being of people, places, and the planet.

Current projects include building carbon-neutral and climate-resilient towns in Hong Kong; low-carbon transport, individual well-being, and planetary health in the era of smart cities and new mobilities; conserving agricultural land in the Northern Metropolis of Hong Kong; oral histories of the Ma On Shan Iron Mine landscape; and a critical review of the *Hong Kong Planning Standards and Guidelines* through the lens of people's right to spatial development for multifaceted well-being.



# 青年研究中心

#### **Centre for Youth Studies (CYS)**

本中心成立於2016年,旨在促進青少年研究跨學科合作,包括社會責任與可持續發展、人才吸納與培育、媒體使用、身份認同、青少年健康、青少年文化等,為香港青少年發展提供數據分析和政策建議。

具體目標為推動香港中文大學各學術單位進行跨學科的青少年研究;建立與海外機構進行合作和比較研究的平台;為香港青少年發展提供具影響力的政策建議。

過往研究項目:香港青少年的健康行為研究;未來軌跡:香港年輕世代對將來的想像、視野、抱負; 青年世界公民倡議與教育。

當前研究項目:畢業生人才配對 模式與由學校過渡到職場的培訓; 食物援助計劃研究與評估; 青少年 發展與介入框架評核確效與遊戲 化;中小學義工體驗式學習網上教 材庫設計與製作。 Established in 2016, CYS aims to coordinate and synthesize research efforts involving different approaches to youth studies. Examples include youth social responsibility and sustainable development, talent attraction and development, youth media consumption, youth identity, youth health, and youth culture.

The objectives of the Centre are to promote interdisciplinary and collaborative youth studies at CUHK and to develop youth studies research as a strategic focus in social science disciplines; setting up a platform for collaborating with overseas academic institutions on comparative youth studies; and generate impactful policy implications for youth in Hong Kong and the region.

Past projects: Health behaviour of school-aged children in Hong Kong; Tracking the future: The perception of the future and aspirations of Hong Kong youth; Promoting youth global citizenship in the Belt and Road Initiative.

Ongoing projects: Strength-based talent matching approach and school to workplace transition; Food assistance programme: Research and evaluation; Youth development and intervention framework assessment validation and gamification consultancy; Development and production of online courseware for school-based volunteerism.



### 經濟研究中心

#### **Economic Research Centre (ERC)**

經濟研究中心於2010年7月成立,前身為香港亞太研究所於1990年創始時已成立的「香港及亞太區經濟研究計劃」。中心使命為推廣有關香港、大中華地區及亞太區經濟問題的研究促進政策討論。現在,中心研究項目包括經濟政策、金融市場、經濟教育、貿易與發展,並就各課題舉辦國際會議、研討會及論壇。

中心成員為專注於香港及亞太區 經濟研究的學者,除香港中文大學的 學者外,亦包括校外知名的學者、專 家。中心成員就其專長,擔任眾多政 府諮詢組織的顧問,以及多個學術機 構的領導人及國際學報編委。 ERC was established in July 2010. The Centre originated from the upgrading of its predecessor, the "Hong Kong and Asia-Pacific Economic Programme", which had been part of the HKIAPS since its inception in 1990. The mission of the Centre is to promote research and stimulate policy discussions on economic issues involving Hong Kong, Greater China, and the Asia-Pacific region. The Centre currently undertakes programmes related to economic policies, financial markets, economic education, and trade and development. It holds international conferences, seminars, and forums on relevant topics.

Members of the Centre include reputable scholars from CUHK and other universities. Many of them have served as advisors in government advisory committees, heads of various academic organizations, and editors/editorial board members of international academic journals.

# 性別研究中心

#### **Gender Research Centre (GRC)**

性別研究中心是香港首個以性別及婦女問題為研究目標的研究組織,於1985年創立,名為「性別研究計劃」,後於2000年易名為「性別研究中心」。中心的使命是提高對性別及婦女研究的知識,以及支持提倡性別平等及婦女地位的行動。

過去三十年,本中心一直致力推 動及開展有關性別議題及性別平等的 學術研究。有關研究包括香港婦女的 地位和挑戰、有關性取向的歧視、性 別定型和香港陽剛氣質的建構等。

2016年8月,性別研究中心設立性小眾研究計劃,是為全港首個研究性小眾的獨立研究計劃。該計劃特別集中研究性傾向、性別認同、法律與社會政策等議題。

GRC is the first unit dedicated to researching gender and women's issues in Hong Kong. Established as the "Gender Research Programme" in 1985, and renamed the "Gender Research Centre" in 2000, the Centre promotes knowledge arising from research on issues affecting women, and supports actions that enhance gender equality and the status of women.

For over three decades, the Centre has supported research related to gender equality. Recent research projects involve investigating the status of women in Hong Kong, the challenges that women face, including discrimination based on sexual orientation and gender stereotyping, and the construction of masculinity in Hong Kong.

The Sexualities Research Programme (SRP) was established in August 2016 under the Gender Research Centre. SRP is the first research programme in Hong Kong dedicated to conducting research on issues of sexuality, with a focus on sexual orientation, gender identity, and law and social policies.



### 國際事務研究中心

#### **International Affairs Research Centre (IARC)**

國際事務研究中心在2012年創立,旨 在探討亞太地區和全球範圍內重要的 雙邊、地區和全球問題,參與政策制 訂和學術圈以外的公共討論。

2012年, 中國印度關係計劃成 立,旨在透過集結和分析中國和印度 媒體對兩國關係的報道,促進兩國計 會不同階層對當代「中印」(Chindia) 概念的認知。

本中心定期舉辦學術研討會和公 開講座活動,邀請本地或海外學者主 講,目標在於發揮橋樑角色,推動本 地對國際事務議題的關注。

Founded in 2012, the aim of IARC is to strengthen and enhance scholarly understanding of key bilateral, regional, and global issues affecting the and world, Asia-Pacific region the contributing to policy development and public discussions beyond academia.

The Sino-Indian Relations Programme was set up in 2012. Through collecting and studying news reports about the bilateral relations of both countries, the aim is to enhance understandings and perceptions of "Chindia" across different sectors in the societies of China and India, as well as their interactions in the field of politics, economics, and culture.

To bridge society and academia, the Centre invites local and overseas scholars to enhance our society's understanding of international affairs by hosting academic conferences and public seminars on a regular basis.



### 公共政策研究中心

#### **Public Policy Research Centre (PPRC)**

公共政策研究中心於2005年成立,旨在推動香港中文大學校內各學術單位進行跨學科的公共政策研究。成立初期,中心以舉辦「香港公共政策論壇」及進行具體的政策顧問研究為主。

近年鑑於香港社會的政治及社會形勢變化劇烈及迅速,本中心的研究重點以青年研究、教育與就業研究、香港及社區研究三條主線為重,希望能深入揭示社會狀況,為學術界及政界辯論香港公共事務及政策發展時提供學術理論基礎。

PPRC was established in 2005 as an interdisciplinary research unit. The Centre strives to promote public policy research in Hong Kong, the Pearl River Delta, and the larger Asia-Pacific region. In the first few years following its establishment, the Centre organized Public Policy Forums about once a year, as well as other seminars and conferences.

In recent years, in response to emerging social and political changes, the Centre has been placing more emphasis on conducting research in the following three areas: Youth studies; education and transition to work; and Hong Kong and community studies. It is hoped that the findings can provide a solid basis for the discussion and formulation of relevant public policies.



# 城市與區域發展研究中心

#### Research Centre for Urban and Regional Development (CURD)

城市與區域發展研究中心致力成為亞 太區內領先的城市與區域發展研究基 地,力求進一步強化並連繫校內和校 外的研究力量,以推動區內(尤其是 中國)的城市與區域發展的基礎與應 用研究。

本中心研究世界城市、全球化、 城市化、中國城市化,覆蓋粤港澳大 灣區、泛珠三角、長三角、中國沿海 和中國西部等地。近年的研究包括香 港、粤港澳大灣區城市和國內其他城 市的發展、規劃、融合與管治,以及 中國的人口遷移與城市化、城市競爭 力與智慧可持續發展。

CURD strives to be a leading research base for and regional development in Asia-Pacific region, and endeavours to promote basic and applied research on urban and regional development in the region, especially in China.

The Centre has undertaken research on globalization. and Guangdong-Hong urbanization the in Kong-Macao Greater Bay Area (GBA), the Pan-Pearl River Delta, the Yangtze River Delta, coastal and Western regions. Ongoing research topics include development, planning, integration, and governance in Hong Kong, GBA cities and other cities in China, migration and urbanization, and urban competitiveness and smart sustainability in China.



# 中國法制研究計劃

#### **Chinese Law Programme (CLP)**

中國法制研究計劃致力成為亞太地區具有影響力的中國法律制度學術研究計劃通過組織多元的學術活動,推動有關中國法律和制度的國際學術交流,研究中國法律制度與其社會、經濟和政治環境的互動關係,從社會、政治經濟和人文等多視角拓展對中國法律制度的深入研究。

研究方向包括中國法律與社會、中國法律與政治經濟、中國法律與政治經濟、中國法律與勞工保護、中國法律與爭端解決、「一國兩制」與跨境法律問題、中國法律與全球化等。

CLP aspires to establish itself as an impactful platform in the Asia-Pacific region for research on Chinese law and legal institutions. By organizing a wide variety of activities, the aim is to approach Chinese law from different perspectives. The Programme conducts research on the inter-relationship between the legal system in China and its wider social, economic, and political contexts, using an interdisciplinary approach.

The themes of the Programme include Chinese law and society, Chinese law and political economy, Chinese law and criminology, Chinese law and labour protection, "One Country, Two Systems" and cross-border legal problems, Chinese law and globalizaton, and others.



# 政策研究網絡

#### Policy Research @ HKIAPS

政策研究網絡成立於2018年1月·是一個跨學科的研究平台,致力匯聚人才,推動卓越和以實證為本的公共政策研究,加強學術界與政策制訂者的交流合作,以及轉化中大學者的研究成果為公共政策和研究影響力。

主要政策研究領域包括:國家發展 戰略與實施、社會人口轉變與福祉、 經濟發展與所得分配、科技發展與創 新,以及環境規劃與可持續發展。首 階段的發展重點是整合本校的公共政 策研究力量,以支援政府施政與發展 策略,尤其是香港如何參與並受惠於 「一帶一路」和粵港澳大灣區建設。 Policy Research @ HKIAPS is an interdisciplinary platform that was established in January 2018 to advance high-quality and evidence-based research on public policies, to promote collaboration between the academic and policymaking communities, and to translate academic research by CUHK researchers into public policies and research impact.

The work of the platform mainly focuses on five research clusters: National strategy and implementation, sociodemographic change and wellbeing, economic growth and distribution, technological development and innovation, and environmental planning and sustainability. In the initial phase, we are focusing on research strengths within CUHK and on aligning them with the government's policy priorities and regional development strategies, particularly with the Belt and Road Initiative and the Greater Bay Area development plan.



# 南中國研究計劃

#### **South China Programme (SCP)**

南中國研究計劃通過發放資助支持以中國為主題的研究項目,鼓勵校內同仁藉研究成果促進公共政策的制訂。本研究計劃覆蓋香港、中國內地及其與澳門、台灣和世界各地聯繫的學術課題。個人學術研究、跨學科合作,以及亞太地區之間內外合作,均在本研究計劃考量之內。

到2016年為止,本研究計劃共資助了九十八項研究。研究計劃同時資助兩項長期研究項目:(一)香港文化指標項目;(二)民間歷史檔案庫。

SCP offers grants to conduct research on China with the aim of encouraging scholars in the University to inform policy formulation through their research findings. The Programme covers studies on Hong Kong and mainland China, as well as their connections with Macao, Taiwan, and beyond. The Programme supports individual research, interdisciplinary collaboration, and research partnerships across and outside the Asia-Pacific region.

As of 2016, the Programme had funded 98 research projects. Simultaneously, it has been supporting two long-term projects: Cultural Indicators of Hong Kong Programme; and Archive on Folk History in China.





### 全球中國研究計劃

#### Global China Research Programme (GCR)

全球中國研究計劃於2015年9月成立,致 力推動有關中國參與國事務的跨領域、多 學科研究。本計劃立足香港、着眼世界, 主要研究方向包括:

> 「一帶一路」倡議的經濟機遇與挑戰; 國際社會對中國影響力的態度與反應: 促進區域合作的制度架構,及 中國對外文化知識的交流與海外華人。

目前,本計劃的成員來自中文大學12個 研究單位及十所學院,參與計劃的47位專 家學者下攬手開展研究項目、籌辦活動、 發表成果。本計劃已與34個「一帶一路」 國家建立研究網絡。研究合作範疇包括: 綠色經濟、藝術文化、資訊科技、公共衛 牛、海外華人等。

Established in September 2015, GCR is a multi-disciplinary research programme with a global vision and a mission to promote research work relevant to China's global engagement. Our strategic research clusters are:

> Economic opportunities and challenges arising out of the Belt and Road Initiative; Reception of and reactions to China's global outreach;

> Institutional framework of coordination for regional cooperation; and

> Humanistic ramifications and overseas Chinese.

At present, 47 researchers and experts from 12 CUHK research units and seven Faculties have joined hands to initiate research projects, organize events, and disseminate output. We have built a network of collaboration in 34 Belt and Road countries. The research collaboration is in aspects such as green finance, arts and culture, information technology, public health, overseas diasporas, and other areas.



# 出版、會議及培訓組

#### Publication, Conference, and Training Unit

香港亞太研究所致力推廣有關香港及 亞太地區社會、經濟與政治發展的社 會科學研究,貫徹出版優秀的學術研 究成果,出版系列包括:亞太廿一世 紀叢書、研究叢刊、政策報告、研究 專論系列,以及公共政策論叢等,成 績有目共睹。出版品於香港及澳門各 大書局發售,亦定期贈予本地決策 者、公共圖書館,以及本地和外地的 學術或研究機構。



The aim behind the publications of HKIAPS is to disseminate and promote research on social, economic, and political developments in Hong Kong and the Asia-Pacific region. Four publication series, namely the Asia-Pacific in the 21st Century Book Series, Research Monograph Series, Occasional Paper Series, and Public Policy Forum Series, are regularly produced. HKIAPS publications are sold at major bookstores in Hong Kong and Macao. Presentation copies are sent to local policy makers, public libraries, and a number of local and overseas academic/research institutes.

Since 2011, HKIAPS has been operating a training programme to provide comprehensive courses for professionals in government and various industries. In 2014, HKIAPS began extending this programme overseas, cooperating with institutions in Instructors of the HKIAPS training programme are leading scholars and experts in the academic, cultural, economic, and political sectors in Hong Kong. The courses include not only lectures, but also discussions, group activities, site-visits, and face-to-face interactions with professionals in various industries. The learning environment enables participants to gain more insights, develop a broader outlook, and become more open-minded.







### 電話調查研究室

#### **Telephone Survey Research Laboratory (Tel Lab)**

電話調查研究室成立於1995年,宗旨 為向有意利用電話訪問作抽樣調查的 學者及社會機構提供專業服務。本研 究室對公共事務作定期的民意調查, 並發布有關結果,以此作為大學與社 會大眾的溝通橋樑。同時,本研究室 亦非常重視知識轉移的工作,讓公眾 對社會調查(尤其是民意調查)有更 深入的認識。

本研究室共有六十個電話訪問工 作站,可於同一時間應付大樣本調查 的需要,乃香港學術界具規模的電話 調查研究組織之一。

Tel Lab was established in 1995. Its mission is to professional support services researchers and social organizations intending to use telephone surveys for their research. It also regularly conducts opinion polls on issues of public interest and releases the results to the public so as to serve as a bridge linking the University and the public. Moreover, the Tel Lab values the importance of knowledge transfers and aims to improve the public's understanding of social research (especially of opinion polls).

Tel Lab is equipped with 60 telephone workstations that can operate simultaneously to handle large samples. It is one of the largest telephone survey research units among local academic institutions.
